




Fig. 1 - Typical Output Characteristics, T_J = 25 °C




Fig. 2 - Typical Output Characteristics, T_J = 150 °C




Fig. 3 - Typical Transfer Characteristics




Fig. 4 - Normalized On-Resistance vs. Temperature






Fig. 5 - Typical Capacitance vs. Drain-to-Source Voltage




Fig. 7 - Typical Gate Charge vs. Gate-to-Source Voltage




Fig. 8 - Typical Source-Drain Diode Forward Voltage




Fig. 9 - Maximum Safe Operating Area




Fig. 10 - Maximum Drain Current vs. Case Temperature




Fig. 11 - Typical Drain-to-Source Voltage vs. Temperature






Fig. 13 - Switching Time Test Circuit




Fig. 14 - Switching Time Waveforms




Fig. 15 - Unclamped Inductive Test Circuit

Fig. 16 - Unclamped Inductive Waveforms





Fig. 17 - Basic Gate Charge Waveform

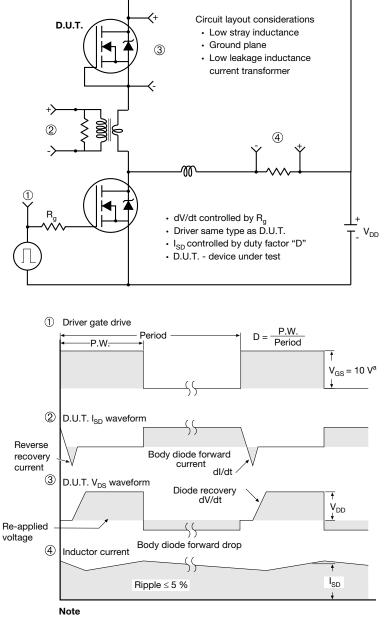
